- An agreement shall be made between the vendor and N.A.C for a term of 01 (one) year and the extension depends on the decision of the council.
- He/She should deposit an amount of Rs.15,000/- (Rupees fifteen thousand) only towards "Security Deposit" after which the cabin shall be supplied to the eligible person.

- Any other conditions as per rule be intimated at the time of allotment of room during agreement.


The last date for submission of application is 11th February'2023 and the date of lottery be published after receipt of application from all concerned and verification of the applications.




